## Water Restrictions Lifted

All Stonehenge residents are currently allowed to water their lawns, wash their vehicles, and fill their pools, without facing tickets or possible service interruptions.

The City Council voted unanimously on May 2nd to end the mandatory Stage 2 water restrictions that have been in place for all City of Raleigh water customers since last year. Stonehenge residents who were on water supplied by Heater Utilities (now DBA Aqua America, Inc.) were not affected by the decision and were not previously under restrictions.

Residents should watch for further news this month as the City Council will vote in mid-May on recommendations for long-term water conservation, which means that there may be new restrictions at that time.

## **Stonehenge Yahoo Group Highlights**

*Here is some of the useful information shared on the Stonehenge yahoo e-mail group.*

### **Lawn care recommendations from homeowners:**

Most of Stonehenge has fescue grass. The common recommendation is never cut tall fescue shorter than 3.5". By letting tall fescue be tall it forces root growth. We have a clay soil which should be de-compacted annually, core aeration improves soil breathing and water absorption, and the cores brought up contain microorganisms which help break down thatch, and micronutrients that don't dissipate so are not normally included in fertilizers.

Good fescue can take several years of seeding in the fall to get full coverage. Soil preparation is the first step. Get a chemical analysis and see what treatments are needed. Variables like drainage, sunlight, trees that suck up water, etc can lead to different results in adjacent lawns.

### **Information on reliability of our electrical service:**

Electricity is remarkably reliable in Stonehenge. Not only are the neighborhood lines underground, but we are close to Progress Energy transmission lines. Our power is usually the first to come on after an outage.

# City of Raleigh Regulations for Home-Based Businesses

The Homeowners' Association has had several questions about the subject of home-based businesses and the regulations governing them by the City of Raleigh. Most of Stonehenge is within the city limits of Raleigh; however, there are some sections that are not. We contacted the City of Raleigh Zoning and Inspections Department as well as the Wake County Zoning Department to get the "straight scoop" as to what home-based businesses can and cannot do. For the most part, the rules are similar in both the city and county locales and very straightforward. Here they are:

1. The business must be carried on by the residents. It may be a sole proprietorship or a corporation that is wholly owned by the residents. It may also be a partnership where all of the partners are residents of the structure. In other words, all employees of the business must live at the residence.
2. Display of goods, products or services may not be visible from outside the dwelling.
3. The business may not exceed 25% of the livable portion of the dwelling or 500 square feet, whichever is less. The house may not be altered and construction features not customarily found in homes may not be added to accommodate the business. Wake County is more liberal on this point and allows up to 50% usage.
4. Outside storage or accessory buildings may not be used for the business.
5. Only handmade items, food and crafts may be offered for sale on the premises. No other goods, products or commodities bought for the purpose of resale shall be sold - at retail or wholesale - on the premises. Inventory may not be stored or displayed on the premises.
6. Equipment may not be used which creates noise, vibrations, glare, fumes, odors or electrical interference "detectable to the normal senses" of others that are off the property (neighbors). No equipment can be used that interferes with any radio or TV reception of neighbors.
7. Off-street parking shall be provided in accordance with City Code 10-2081. Off-street parking shall be maintained in addition to the spaces required by the residents itself. No parking in yards to accommodate customers. Parking is allowed only in driveways.
8. *This regulation causes the most questions and is more restrictive for those homes located in the city limits of Raleigh. Only one vehicle used in connection with the business shall be parked or stored on the premises. The vehicle may not be a large or oversized truck such as, but not limited to, a dump truck. Advertising may not be displayed on the vehicle as a substitute for signs for the business. (There are other ordinances governing the amount of signage that can be placed on a vehicle which belongs to a home-based business and is kept at the residence. And, this wording does not apply to business vehicles that are owned by businesses not located at the residence. See the Special Use Permits section*

In simple terms, a home-based business cannot have signs on the vehicle it keeps at the residence. It should be noted that this regulation does not prevent an employee of a commercial business from parking a business vehicle with signage at a residence overnight.

Residences that are not within the Raleigh City limits have some options for displaying signs that are allowed for Wake County houses. Details are available in the Home Occupation guidelines within the Wake Count Unified Development Ordinance.

9. No person other than members of the family residing in the dwelling shall be engaged or employed in the business.
10. No specialty service for groups, such as dance lessons, crafts or music lessons shall be provided for a group larger than 5 people.
11. The exterior character or appearance of the dwelling shall not be altered or changed to accommodate the business.

As you can see, the rules easily allow the operation of a home business while also providing protection for neighbors. Businesses such as in-home baby sitting, tax preparation, web design, IT consulting or computer support are some common examples of home-based occupations which easily fit into these guidelines. The rules even allow for customers or clients to visit a residence to conduct business with the home-based enterprise — as long as the parking requirements are met.

One resident's suggestion is to talk to the neighbors closest to you if you are thinking of starting a home-based business. It is a good idea to let them know that you intend to operate within the regulations set forth by the City of Raleigh or Wake County. You may avoid misunderstandings and hurt feelings down the road. Don't forget that you'll need a privilege licenses from the City of Raleigh or from Wake County as well!
