

## Watch Your Speed

The Board has received several complaints about speeding on North Creek Run. In an attempt to draw attention to the speed limit signs, the Board asked the Department Of Transportation to investigate placing warning flags atop the speed limit signs.

The request was denied as explained in the following letter from Frank Carpenter of the DOT.

"Your request for flags to be placed on the existing speed limit signs in your subdivision was investigated on 2-1-05. Based on our investigation flags are not warranted at this time. There are posted 25 mph signs throughout the subdivision and flags are normally used for a "new" traffic pattern or situation. The enforcement of the posted speed limit would reduce the speeding complaints from the subdivision. The Sheriff's office or Highway Patrol can help with the enforcement. Please let me know if I can be of further assistance."

## PINE STRAW UPDATE

Our pine straw vendor experienced problems obtaining quality pine straw this year. He made a partial delivery, but stopped after it became clear that the pine straw was unacceptable. The second shipment was only marginally better than the first one.

Rather than continuing to hold everyone's check without knowing when the next shipment would arrive, we decided to return the checks, including those who received their bales, so the purchasers could make alternate arrangements. We apologize for any inconvenience this may have caused.

## Connect with your Neighbors Online

We are a large community of busy people. Indeed, there are limited opportunities to cross paths and greet each other in person, and information tends to flow rather slowly through the neighborhood 'grapevine'. But virtually everyone uses the Internet, and Stonehenge residents have common access to a virtual 'bulletin board' – the Stonehengehoa group listserve hosted on Yahoo!

Typically, just a handful of messages are sent each month. Representative postings are innocuous but useful -- neighborly offers of items free for the taking, notices of and requests for teens available for babysitting duty, bulletins regarding lost and found pets, yard sale announcements, FYIs from your Homeowners' Association board about upcoming events, etc.

**And, group list participation directly supports the safety and security of our community...**

During the wee hours of Friday, March 4, mine was one of several properties burglarized in the Stonehenge community located west of Ray Road. Shortly after the investigators left my home, I posted an advisory to warn others about the crime and to seek corroborating information. Through the resulting discourse, we inadvertently identified a two-year pattern of unresolved break-ins within greater Stonehenge. The good news is that the perpetrator of the recent incident was apprehended (and summarily convicted); even better news is that our group list correspondence enabled several otherwise disconnected parties to collaborate and 'connect the dots' about previous incidents.

Through this experience I learned that many residents maintain individual Email distribution lists of various neighbors but that relatively few of us are subscribed to the larger Stonehenge group list. Please join the Stonehenge HOA group list and get 'in the loop' about matters of community interest. Equally important, greater participation in this virtual 'grapevine' will increase awareness and make ours an even safer neighborhood for all.

### How do I join the online community?

The easiest way is to go to the Yahoo! Groups home page: <http://groups.yahoo.com/group/stonehengehoa>. Please click the "Join This Group" link on the left-hand side. If you have a Yahoo! account, you can sign in, or you can create one. Click the "Join This Group" link and then the "Sign Up Now" link. If you don't want to create a Yahoo account, another way to join the group is to simply send a message to [stonehengehoa-subscribe@yahoogroups.com](mailto:stonehengehoa-subscribe@yahoogroups.com). Yahoo will respond with an e-mail containing a link to their Web site that will allow you to join.

Once you've selected the "Join" link, scroll to the bottom and select the gray "Join" button. Once you submit this page, I will receive an e-mail from Yahoo. I will respond to your e-mail with a simple question (if you live in the neighborhood, you'll know the answer). When you answer that question correctly, I will make you a full member of the group. The board decided to put this filter into place to keep spammers from joining the group.

Once you're a full member, you should define the options for your account from the home page by selecting the "Edit My Membership" link in the upper right. You can post messages to the group either from the home page, or by sending e-mail to [stonehengehoa@yahoogroups.com](mailto:stonehengehoa@yahoogroups.com) (make sure you send it from the same e-mail account in which you receive messages).

## Wellsley Way to be Extended to Strickland Rd.

We have recently learned that plans to extend the north end of Wellsley Way connecting it with Strickland Road have been approved. According to information sent to us, construction is set to begin in about two to three months. Fourteen homes will be built along the road extension.

An unnamed source at the Department of Public Works stated that the developer originally requested that the home sites be built on a cul-de-sac off of Strickland Road. However, the City of Raleigh required that the road connect to Wellsley Way because of city access code requirements. Unfortunately, it appears that there is nothing that the Stonehenge Homeowners' Association can do to alter or halt this plan.


